## Power of Attorney (POA) Overview

- Designate someone else to carry out activities, such as banking, real estate transactions
- Only valid when you are live
- Two types
  - Limited POA very specific activities
  - $\circ$   $\,$  General POA only valid for one year and need to renew at the same notary  $\,$
- Useful when you are sick, incapacitated, or travel

### Ecuadorian Will Overview

- EC will for EC asset and home country will for home country assets
- Recommendation You should have a EC will if you want to ensure that your asset is distributed according to your wishes, especially
  - you have any kind of assets in Ecuador and/or
  - Unique personal situations (marriages, 2nd marriages) and/or
  - You want to pass your assets to non-family members or charities
- EC Inheritance laws is Family based
  - $\circ \quad \text{For singles}$ 
    - No children can go to other people/charities but must have a will
    - Has children all goes to children
  - For couples
    - Any asset acquired after marriage will be 50% husband and 50% wife unless there is prenup or postnup
    - If one spouse passes away, let's say the husband passes away
      - Have children The husband's portion goes to children. So the wife will have 50% and children has 50%

- No children the husband's portion will either go to the wife or other people if he wishes it with a will.
- However, the inheritance/transfer of assets does NOT happen automatically. It needs an Effective Possession Contract after one passes away for it to happen.
- Two types of Wills
  - Open will
    - for those who is fluent in Spanish
    - Need 3 witnesses
    - Read by the notary
    - Original copy will be delivered to you
  - Closed Will ("Secret Will")
    - Those who are not fluent in Spanish
    - Need 5 witnesses
    - Only you and your lawyer who did the will know what is in the will
    - Will only be opened after you pass away
  - $\circ$  Changes to the will need to be a brand new will. So try to be relatively general
- Cannot have joint wills. For a couple, each person needs their individual will.

# Ecuadorian Advance Living Will (New law) Overview (aka End of Life Will)

- In the US, it is often called
  - advance healthcare directive or
  - living wills or
  - durable powers of attorney for health care
- is a legal document that states your wishes for medical care if you are unable to communicate them, such as if you are in a serious illness or injury. It can also give someone else the authority to make medical decisions for you
- They can include instructions about:
  - Life-sustaining treatments, like breathing machines and feeding tubes
  - $\circ$   $\,$  Organ and tissue donation
  - Cardiopulmonary resuscitation (CPR)
- Can also add instructions for burial services/cremation
- Example of a client that you are the representative for the Living Will

- 3. Real estate
  - a. Leaving real estate to someone other than children living in the USA
  - b. Disposition of our house and capital gains taxes at death
  - c. If I am the only person on our escritura (i.e. deed), how does our house pass to my wife?
  - d. What happens to any real estate property I own once I die, especially in how my heir (s) will be able to sell or continue to own it if they choose? Can they use it to obtain investment residency if they want?
- 4. Charity Giving
  - a. May I leave a portion of my estate to the church/orphanage/non-profit organizations/charities?
  - b. Inheritance tax implications of leaving to charities
- 5. Spouses/Families
  - a. We are an expat couple living in Ecuador. What happens if I die at home (due to illness or a sudden heart attack), What should my partner do?
  - b. I am a single expat living alone in EC and all my families are in the US/Canada and do not speak Spanish. What happens when I die?
  - c. I have lived with my Ecuadorian partner for many years but not married. What happens to my asset or hers if one of us passes? Is there such a thing as common law marriage?
- 6. Burial/Cremation Services
  - a. How to arrange either burial or cremation in EC?
  - b. How to arrange remains or cremains (after creation) to my home country (9 generation family lot)
  - c. How will the family be notified?
- 7. Sara's/EcuadorVisas' Services
  - a. Can you, as my attorney, be my executor in the event of my passing?
  - b. Will you obtain a death certificate and submit it to my fiduciaries?
  - c. Do you have a representative in other cities in Ecuador other than Cuenca?
  - d. What are your fees for these three documents?
